Effective August 1, 2024 — Wonderful College Prep Academy Delano (2070 Veneto Street, Delano, CA 93215) and Wonderful College Prep Academy Lost Hills (14848 Lamberson Avenue, Lost Hills, CA 93249) will be serving program-compliant meals and milk at no charge to enrolled students until June 6, 2025.
